### **RELEASE AND WAIVER OF LIABILITY**

As consideration for my participation in the Horseshoe Classic High School Football Game which will be held at Lucas Oil Stadium ("Stadium") on August 17, 2018 (the "Event"), the undersigned agrees as follows:

1. I acknowledge that I have voluntarily chosen to participate in the Event at the Stadium.

2. I acknowledge that the Indianapolis Colts, Inc., a Delaware corporation ("Club") and the Capital Improvement Board of Managers of Marion County, Indiana ("CIB") and their directors, managers, officers, employees, independent contracts, volunteers, agents, and affiliates of Club and CIB shall not be responsible for monitoring my participation in the Event in any way or my use of the property, equipment and/or facilities of Club, CIB or **Lawrence Central High School** ("School") (collectively, the "Property").

3. I ACKNOWLEDGE THAT MY PARTICIPATION IN THE EVENT AND MY USE OF THE PROPERTY CAN EXPOSE ME TO RISK OF INJURY FROM OBVIOUS DANGERS, HIDDEN DANGERS, ACCIDENTS, MISHAPS, AND CONDITIONS OR ACTS OF OTHER PERSONS, AND THAT THE EVENT IS A POTENTIALLY HAZARDOUS ACTIVITY. I UNDERSTAND THAT FOOTBALL AND/OR CHEERLEADING AND RELATED ACTIVITIES INVOLVE CERTAIN RISKS, INCLUDING BUT NOT LIMITED TO, DEATH, SERIOUS NECK AND SPINAL INJURIES RESULTING IN COMPLETE OR PARTIAL PARALYSIS, BRAIN DAMAGE AND SERIOUS INJURY TO ALL BONES, JOINTS, MUSCLES AND INTERNAL ORGANS. I AM VOLUNTARILY PARTICIPATING IN THIS EVENT WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL INHERENT RISKS OF PROPERTY DAMAGE, PERSONAL INJURY OR DEATH.

4. I understand the risks involved and hereby voluntarily assume all responsibility for risk of injury to myself, whether disclosed or not, and do not expect to receive any other warning or other information concerning the possible risks of injury to myself.

5. In return for my participation in the Event and my use of the Property, I hereby relieve, release, discharge, and hold harmless Club and CIB and their directors, managers, officers, employees, independent contracts, volunteers, agents, and affiliates of Club (collectively referred to as the "Releasees") of all responsibility and liability to myself and/or my estate, representatives, heirs, assigns, and next of kin for all loss or damage, and any claims or demands therefor, on account of injury to my person or property or resulting from my injury or death, which arise from my participation in the Event and/or use of the Property, whether caused by the negligence of any of the Releasees or otherwise.

6. I represent and warrant that I am at least eighteen (18) years of age at the time of signing this Release and Waiver of Liability or, if I am under eighteen (18) years of age at the time of signing this Release and Waiver of Liability, a parent or guardian has also signed this Release and Waiver of Liability and has fully consented and acknowledged the terms and conditions herein.
